- Your Band will perform for a period of 45 to 60 minutes every day during the period of engagement in one or two sessions. The exact timings of performance will be indicated to you by the Management.
- 4. Your Group will be given off-days on Mondays.
- 5. Your Band will be paid at the rate of Rs. 3, 200/- for the above mentioned period of 30 days on expiry and satisfactory completion of your engagement. You, as a Leader of the Band, will receive the payment and issue a receipt on receiving the amount from us.
- You, as the Leader of the Band, will be responsible for the discipline, punctuality and performance of the Band and the Management will not be dealing with any individual member of the Group. You will be responsible to Mr. K. B. Menon or to any other officer on duty at the time and place of Registered Office: Bombay House, 24 Bruce Street, Bombay-1.

- 7. If the Band fails to perform on any day for any reason whatsoever or remains absent, with or without our permission, we shall deduct pro-rata amount for the days not performed.
- 8. You will be required to bring your own instruments.
- 9. If any member of your Group remains absent for any reason whatsoever, it will be your sole responsibility to see that an equally good and talented substitute is arranged, so as not to upset the performance for that time.
- 10. The Management reserves the right to advertise the performance of the Band and/or any of its members individually in any way found suitable by the Company.
- 11. Please note that in the event of the provisions of the Employees Provident Fund Act, 1952, being made applicable to you and/or any member(s) of your Band, you will be liable to pay the necessary amount by way of Provident Fund, including inspection charges as determined/demanded by the Provident Fund authorities. The amount as and when it becomes due and payable will be deducted by us from your salary which please note. You are requested to let us know the names of persons comprising your band and salaries paid to them every month. You should also maintain a salary and attendance register.
- 12. This contract on its expiry may be renewed for such period and on such terms and conditions as may be mutually agreed to.
